Trustee Harding moved to transfer \$9056.19 from General Savings to Police Operations Checking to cover bills and payroll. Scranton seconded.

President Bong informed the Board that the Village's bonds have been purchased Wednesday, November 15, The final closing and money transfer will take place on the 30th. Attorney's fees, as well as fees for Bernardi's, S&P, Wolf/Tesar, and Chapman & Cutler will be paid from the original transfer.

Trustee Scranton suggested the Village enroll in the IPWMA network at a cost or \$100. He hopes to have a model resolution available for the December 4 meeting. (Illinois Public Works Municipal Aid)

Trustee Getz announced that the new pick-up truck is in and operational but still awaiting a light package. The old truck will be cleaned up and made ready for sale.

Eric Hansen, Zoning Board Chair, explained that the Zoning Board concentrated on the duties/role of the Zoning Code Enforcement Officer. The ZB made 2 recommendations:

- 1. the ZCEO would perform a final inspection which would include a Certificate of Occupancy (Zoning Compliance).
- 2. the ZCEO would perform a preliminary set-back and footage inspection prior to actual construction and close out paperwork.

The Village Board will define the level of inspection and wording included in ordinance.

Adam Hodgson from CMT was present to explain the MFT audit through IDOT, indicating that the state will no longer reimburse funds retroactively. All MFT work must be approved before work is done.

Trustee Zuercher moved to adjourn to **Executive Session** to discuss personnel, and Scranton seconded.
