4. **Intergovernmental Agreement – School Resource Officer:** Trustee Hinman discussed a having a one-year agreement and the overall goals; promote a good working relationship with the school, presence of more authority for the school as the procedures for disciplinary have changed. Public Works Sup. discussed with the board the possibility of the property owner of 209 East St. putting in white rock in front of their house instead of concrete or asphalt as it would run over a water line.
