Public Comments Accepted for the Comprehensive Plan

The Comprehensive Plan for Tremont is available for review on the Village's website at tremontil.gov and at the Village Hall and Library. You can also click the button below. Public comments will be accepted through December 15 and placed in the document. The Village Board of Trustees is scheduled to act on the Comprehensive Plan on December 19.

While the Village Board commissioned the plan through a partnership with the Tri-County Planning Commission, all community groups and taxing bodies can benefit from the data collected. A comprehensive plan is a critical component as the inevitable changes over time occur in every community. Evaluating current strengths and weaknesses can assist leaders and community groups as they grapple with their collective visions for the future.

Did you know...?

The Tazewell County Poor Farm in Tremont

Before the Social Security Act was passed in 1935, each county or town took care of its own poor, along with the mentally ill, disabled, and homeless populations. In Tazewell County, this took place at the Tazewell County Poor Farm, or Poor House, located on the property where the Tazewell County Health Department is today, about two miles West of Tremont, off State Route 9. Originally, around 1870, it was located on Robison farm property nearby. On March 5, 1877, the (Bloomington) Pantagraph stated, "There are at present, 69 males, 47 females and 16 infants. There have been three deaths during the year."

An article in the Pantagraph on August 27, 1900, touts a new building just completed there for the residents on the 224-acre farm, and states that the other buildings on the property were old but in good condition. At that time, there were 82 people housed there, along with staff and the Superintendent who lived in a separate residence sometimes with his or her family as well. The first superintendent of the Poor Farm was Sarah C. Hall, who was

followed by several others.

By 1911, two old frame buildings were to be removed, and the superintendent's home was to be moved 200 feet and turned half-way around. There would be three new buildings: a new residence for the superintendent, a building for females, and a hospital building, all of brick and stone with slate roofs. This building project was full of controversy, though, since the finished work quality was seen as poor, and bills kept pouring in with no one claiming responsibility for the orders.

No one ever wished to be a resident at any poor farm. There was great stigma attached to needing to reside there. In fact, it was a constant issue, even for the children. They were not welcomed by the public school because they supposedly made the school overcrowded, and not as much money was paid to the school as was for other children. Therefore, people felt the children were not legally entitled to attend the schools. But one report from 1873 stated that the County Board Poor House Committee had recently visited the Tazewell County Poor Farm, and, "by observation and conversation with the paupers, they found the inmates without exception as happy and well-contented as any class of like persons could be expected to be." Later, in 1900, another article stunningly reveals, "forty of these (residents) are insane or weak-minded and some of them are obliged to be kept locked up."

In 1883, another report mentions that the cost of keeping 73 inmates came to "about \$14.00 a year, 27 cents per week, or 4 cents a day." However, there were times that residents had to be evicted. The Pantagraph of March 18, 1885, listed eight names, saying that these "inmates of the Tazewell County Poor Farm will be taken to the asylum at Kankakee this morning."


It was called the Poor Farm because of the actual, working farm there, where inmates worked as they were physically able. A 1900 news article stated that, of the property, 60 acres was in corn, 35 in oats, seven in potatoes, four in garden, and more in pasture and meadow. There were 100 head of hogs, 20 cows and 12 horses. The article went on to say, "Tazewell has the best and largest garden of any county farm in the state. All the vegetables used during the entire year (at the farm) are grown on the place."

Seven decades after its beginning, the Board of Supervisors on September 10, 1941, voted to "close and abandon the County Home for the use of elderly poor people." About 19 inmates were removed to other quarters. Many were removed to the State Hospital.

Later, the buildings were used for a Home for the Aged (a nursing home), and then a home for Dependent Children (an orphanage).

Tremont Holiday Lights Contest


